**ORDER**

In the Government order first read above, orders were issued revising the pay scales of the State Government employees as recommended by the Pay Revision Commission, 1999 with certain modifications. The Pay Revision Commission on the pay scales of the Secretary, Tribunal for Disciplinary Proceedings, has observed that the post is not in Commissions purview, and as the post is held by a Judicial Officer of the rank of the District Munsiff, which is under the purview of the First National Judicial Pay Commission and orders were issued accordingly in the G.O. first read above.

2. In the reference second read above, the Chairman, Tribunal for Disciplinary Proceedings, has forwarded the representation of the Secretary, Tribunal for Disciplinary Proceedings, that the post is governed by the Andhra Pradesh Tribunal for Disciplinary Proceedings Service Rules, issued in G.O.Ms.No.600, General Administration Department, dated 7.11.1990 as amended in G.O.Ms.No.28, General Administration Department, dated 20.1.1998 according to which the post of Secretary, Tribunal for Disciplinary Proceedings has to be filled in by transfer or by promotion from candidates who are working as District Munsiffs in the Andhra Pradesh State Judicial Services Or candidates who are working as Assistant Secretaries to Government in the Andhra Pradesh Secretariat Service Or candidates in any service who are holding initial Gazetted Post Or by promotion of the candidates holding the post of Superintendents in the Office of Tribunal for Disciplinary Proceedings who have put in five years of service and requested to assign the pay scale as applicable to the Assistant Secretary to Government in the Secretariat.

3. The issue has been examined in detail and after careful consideration, it has been decided to allow the pay scale of Rs. 6950-14425 in the Revised Pay Scales, 1999 to the post of Secretary, Tribunal for Disciplinary Proceedings if the post is filled in by promotion from the category of Superintendent, Tribunal for Disciplinary Proceedings and if the post is filled in by promotion/transfer from the category of District Munsiff in the Andhra Pradesh State Judicial Services Or Assistant Secretary to Government of the Andhra Pradesh Secretariat, he will draw the pay scale of his substantive post.

4. Accordingly, the following notification will be published in the Andhra Pradesh Gazette:

### **NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Revised Scales of Pay Rules, 1999.

### **AMENDMENTS**

In the said rules, in Schedule-II (Departmental Schedules) under "115. Tribunal for Disciplinary Proceedings,"-

(1) against category "1.Secretary" under column " Revised Pay Scale ", the figures "6950-14425" shall be inserted.

(2) under column "Remarks" for the words "Not in commission purview", the words " . If the post is held by an incumbent from the category of Superintendent of Tribunal for Disciplinary Proceedings. Others will carry the pay scale of their substantive posts" shall be substituted
